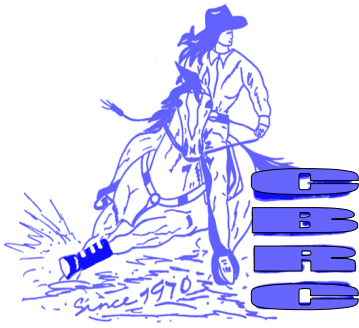

Releaser desires to engage in equine activities sponsored by, or in which Releaser will be using an equine, tack, equipment, facilities, and/or premises, furnished by Release. Releaser understands there are risks in equine activities. As a condition of participation in the equine activities, Releaser (individually and for his/her heirs, executors, assigns, invitees, and minor children) waives the right to bring and releases Releasee and Releasee's administrators, agents, officers, directors, employees, predecessors and successors-in-interest, and any other persons or entities united in interest with Releasee from any and all manner of actions, suits, claims for relief, demands, damages, and any other obligations, known and unknown, suspected and unsuspected, in law or equity, direct or indirect, and whether now or in the future, for any injury or death arising out of or connected in any way with riding, training, driving, boarding, grooming, or riding as a passenger upon an equine. If for any reason any provision of this release is determined to be invalid, the remainder shall continue in full force and effect. If I am being furnished an equine, I acknowledge reasonable and prudent efforts have been made to determine my ability to safely ride, train, drive, groom, or ride as a passenger upon an equine and to manage the equine furnished. If I am being furnished equipment or tack, I acknowledge it has reasonable and prudently been inspected. This release contains the entire agreement between the parties hereto and the terms of this release are contractual, not a mere recital.
